CYPRUS CITIZENSHIP BY INVESTMENT & PR

These recent revisions (as per article 111A (2) of the Civil Registry Law 2002-2013, of the republic of Cyprus) have made the Cyprus Citizenship by Investment program more beneficial for investors and families. In virtue of this law the Cyprus Council of Ministers may grant citizenship by naturalization to foreign entrepreneurs. Additionally, the law provides for the granting of the Cypriot citizenship by Investment to the spouse, children as well as to the parents of the investor.

- o Invest at least 2 million euro in Cyprus real estate for citizenship
- o Invest at least 2.5 million euro in Cyprus commercial property for citizenship
- o Invest at least 300,000 euro in Cyprus real estate for PR
- o Have a clear criminal record obtained in your country of residence.
- o Be a person not sanctioned by the EU.
- o Applicant must be 18 years of age or older
